## **MEMBERSHIP CHOICES AND FEE SCHEDULE COMMENTARY:**

Managing the finances of the BCC and protecting it's long term viability is the challenging job of your Board of Directors (BOD). Keeping fee increases to a minimum is of course our wish, but this needs to be reviewed within the context of our total revenue picture and the rising cost environment. We have run WITHOUT a full-time Manager since before COVID as we could not afford one. We also recognize our facility is aging and we will be facing serious capital expenditures in the coming decade.

In the years pre COVID our Adult Membership numbers had dipped into the 80's and even with bar revenue, rentals and additional fundraising we just barely covered our expenses. Membership at that time was aging and a large percentage of members were only half season members. The VERY difficult decision was made by the BOD at that time to suspend all 1/2 season memberships as it did not bring in the revenue required to pay the bills.

Fast forward to 23/24 season and our picture has improved. This past season our Adult Membership hit 140 and we continue to project growth for the 24/25 season as we are counting on ALL MEMBERS to bring your friends! Given this situation, the BOD has elected to offer once again an "Unlimited 1/2 Season Membership" option. This is being offered at the discretion of the BOD for 63.5% of a total Season Unlimited Membership. It will NOT include a volunteer fee rebate.
